




Veterans' Entitlements Act 1986

Veterans' Entitlements (Church and Charitable Development Fund Exemption) Determination 2016

Instrument 2016 No. M45

I, MARK HARRIGAN, as delegate of the Minister for Veterans' Affairs, make the following determination under subsection 46L(1) of the *Veterans' Entitlements Act 1986* (VEA).

1 Name

This determination is the *Veterans' Entitlements (Church and Charitable Development Fund Exemption) Determination 2016*.

2 Commencement

This determination commences on the day that it is made.

3 Revocation

The *Veterans' Entitlements Act 1986 Determination under subsection 46L(1)* (No.11/2006) made by the then Minister for Veterans' Affairs, Bruce Billson, on 28th day of March 2006 is revoked.

4 Specified financial investments determined not to be financial assets

- (1) For subsection 46L(1) of the VEA, the financial investments mentioned in the table of the Schedule and made to the fund or account named in column A, sponsored by the organisation named in column B, are not to be regarded as financial assets for the purposes of sections 46D or 46E of the VEA from the date specified in Column C.
- (2) This determination applies only to financial investments to a fund mentioned in the table of the Schedule if the investment is made before 1 January 2010.
- (3) To avoid doubt, new investments or top ups to existing investments made to a fund on or after 1 January 2010 are not covered by this determination and will be regarded as financial assets for the purposes of sections 46D or 46E of the VEA.

Note: This determination is not a legislative instrument within the meaning of the *Legislation Act 2003* - see section 7 of the *Legislation (Exemptions and Other Matters) Regulation 2015*. Accordingly, it need not be registered and will not be subject to the sunset, tabling and other provisions of the *Legislation Act 2003* governing legislative instruments.
