Veterans' Entitlements (Electronic Lodgement Approval) Instrument (No. 2) 2016

Instrument 2016 No.R59

The Repatriation Commission, pursuant to subsection 5T(3) of the *Veterans' Entitlements Act 1986*:

1. revokes the instrument entitled *Veterans' Entitlements (Electronic Lodgement Approval) Instrument 2016* (Instrument No. 2016 No. R4) made on 9 August 2016;
2. approves the claims, applications, requests and other documents listed in Schedule 1 for electronic lodgement where the claim, application, request or other document is transmitted electronically;
3. approves the manner specified in Schedule 2 of lodging claims, applications, requests and other documents listed in Schedule 1;
4. approves the electronic addresses listed in Schedule 3 (address) to which a document in Schedule 1 may be transmitted (relevant document) in a manner listed in Schedule 2 provided that at the time of transmission of a relevant document the address is for an establishment a purpose of which is to accept a relevant document.

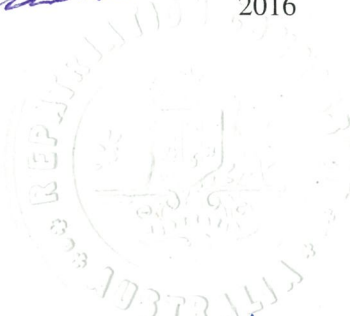


